Excerpt: ...possession thereof for the use of tho owner of the said ground, water, or fishery. XXXI. That if any person shall erase, deface, obliterate, or alter, any brands or other marks on any cattle, sheep, swine, goats, turtle, or fish, such turtle or fish being in a pond or crawl, or put any false mark thereon, with a fraudulent or malicious intent, every such offender shall be guilty of a misdemeanour, and on conviction thereof befdre two Justices of the Peace, shall be liable, at the discretion of such Justices, to be fined in any sum not exceeding twenty pounds of lawful money: and, in default of payment thereof, shall, at the discretion of the Justices, be imprisoned in the common gaol, workhouse, or house of correction, for any space of time not exceeding six calendar months: and if any person, so convicted, shall afterwards be guilty of the said offetace, such offender shall be committed to the common gaol, workhouse, or house of correction, there to be kept to hard labeur for such timo not exceeding twelve calendar months, as the convicting Justices shall think fit. XXXII. That if any person shall steal, or shall cut, break, root up, or otherwise destroy, or damage, with intent to steal, the whole, or any part of any tree, sapling, or shrub, or any underwood, respectively growing in any park, pleasure-ground, garden, orchard, or avenue, or in any ground adjoining or belonging to any dwellinghouse, every such offender, in case of the value of the article or articles stolen, or the amount of the injury done, shall exceed one pound sterling, shall be guilty of felony, and, being convicted thereof, shall be liable to be punished in the same manner, as in the case of simple
